Annex B: Code of Conduct & Safety Rules

At Free Spirit Winter Haven, we aim to create a welcoming, respectful, and safe environment where children are free to explore, learn, and create. These guidelines ensure a positive experience for everyone involved.

1. Respect for Others

- Students are expected to be kind, respectful, and cooperative with instructors, volunteers, and fellow classmates.
- Bullying, teasing, or disruptive behavior of any kind will not be tolerated.
- Students must follow directions given by instructors the first time they are given.

2. Respect for Materials & Property

- All tools, electronics, and learning materials must be handled carefully and returned to their proper place after use.
- Misuse of tools or equipment (including 3D printers, crafting materials, or trains) may result in loss of access to those items.
- Students are expected to help clean up their work area before leaving class.
- Students may not touch others' work without permission.

3. Appropriate Conduct

- Students are expected to remain in designated classroom areas unless given permission to move elsewhere.
- Running, roughhousing, or climbing on outdoor structures (including the garden railway) is not allowed unless part of a supervised activity.
- Students must speak respectfully no shouting, name-calling, or inappropriate language.

4. Safety First

- Closed-toe shoes must be worn during all classes. No sandals or flip-flops allowed.
- In workshop or railroad areas, additional safety gear (such as goggles or gloves) may be required and must be worn when instructed.
- Students are not permitted to use sharp tools, soldering equipment, or power tools without direct supervision.
- No food or drink is allowed in the workshop; water bottles are allowed in class areas.
- Students should wash hands before snacks and after using the restroom.

5. Class-Specific Conduct

Yoga for Children

- Students are expected to participate calmly and respectfully in all activities.
- Talking during mindfulness or quiet portions of class is discouraged.
- Shoes must be removed before entering the yoga area.
- Personal space should be respected at all times.

Art Studio

- Creative freedom is encouraged, but students must clean up their workspaces.
- Paints, markers, and other media must be used only on approved surfaces.
- Clothing may get messy—please dress accordingly.
- Students should not interrupt or touch another student's artwork.

6. Arrival & Dismissal

- Students must be dropped off no more than 10 minutes before class and picked up promptly at the end of class.
- Parents/guardians must sign in and out their children unless prior written permission has been given for older children to arrive or leave independently.
- Children will only be released to the adult(s) listed on their enrollment form.

7. Illness & Hygiene

- Children must be kept home if they have a fever, contagious illness, or have been vomiting within the past 24 hours.
- Students are expected to follow basic hygiene practices (e.g., hand washing before snacks, after restroom use, etc.).
- If a student becomes ill during class, a parent or emergency contact will be called immediately.

8. Consequences for Misconduct

Free Spirit Winter Haven follows a three-step approach to discipline:

- 1. Verbal reminder and redirection
- 2. Temporary removal from the activity or area
- 3. Parent notification and behavior conference
- 4. Dismissal from the program (in cases of repeated or serious violations)

Repeated or severe violations may result in dismissal from the program without refund.

Appendix: Garden Railroad Safety Rules

The outdoor garden railway is a highlight of the Free Spirit experience and is treated as a working STEM lab.

To ensure everyone's safety, students must observe the following:

- Entry to the railway layout is only permitted with instructor permission.
- Students must never step on or cross the tracks unless instructed.
- Hands and tools must be kept clear of moving trains at all times.
- Electrical components and control units must not be touched unless under direct supervision.
- The layout includes trip hazards running and horseplay are strictly prohibited.
- Personal belongings (water bottles, bags, etc.) should be kept outside the layout area.
- Parents are responsible for ensuring appropriate clothing (closed-toe shoes, sun hats, etc.) during outdoor sessions.
